

Data Protection Declaration for the Use of Aracuba GmbH Services

Valid from 24.5.2018

The protection of your personal data is of great importance to us. We only process your data within the realms of legal regulations (DSGVO, TKG 2003). In this data protection declaration, we inform you of the most important aspects of data processing via our website/platform.

The following data protection declaration applies to all services offered by the provider and is an integral component of the provider's general terms and conditions.

By registering, the user expressly agrees to this data protection declaration. The provider is permitted to make changes to this data protection declaration in accordance with the requirements outlined in §11 of the general terms and conditions.

Contacting us

If you contact us via the contact form on the website/platform or via email, the data you provide will be saved by us for six months so we can process your request and any follow-up questions. This data will not be passed on without your permission.

Saving data

We would like to inform you that the following data is saved by the platform operator during member registration: full name, company, country of origin and email address. Furthermore, the following data is saved for the purposes of contractual fulfilment: full name and address. The data provided by you is required for contractual fulfilment and the implementation of pre-contractual measures. Without this data, we are unable to enter into a contract with you. Data is not transferred to third parties except for the transfer of credit card data to the service provider carrying out the payment (PayPal (Europe) S.à r.l. et Cie, S.C.A., 22-24 Boulevard Royal L-2449 Luxembourg) for the purposes of obtaining the membership fee, whereby credit card information will not be saved locally, as well as to our tax advisor (IBD Steuerberatung GmbH & Co KG - Schönbrunner Straße 222 - 228, A-1120 Vienna) to fulfil our tax obligations.

If you cancel the registration process, any data we have saved will be deleted. As the contract is concluded, all data from the contractual relationship shall be saved until the end of the statutory retention period (7 years). Data is processed within the realms of the regulations of §96 section 3 of the TKG and article 6 section 1 a (consent) and/or b (necessary for contractual fulfilment) of the DSGVO.

Cookies

Our website uses cookies. These are small text files that are stored onto your end device with the help of your browser. They do not cause any damage.

We use cookies to make our online presence more user-friendly. Some cookies remain on your device until you delete them. They let us recognise your browser the next time you visit.

If you do not want this, you can set up your browser to inform you each time a cookie is stored or only allow them in certain cases.

If you deactivate cookies, you may be unable to use all functions of our website.

Web analysis

Our website uses functions provided by the web analysis service Matomo (formerly PIWIK Analytics) - 150 Willis St, 6011 Wellington, New Zealand - whereby no data is transferred to the company. To this end, cookies are used that facilitate the analysis of website use by users. The information created is saved on local servers of the platform operator.

You can prevent this by setting up your browser to prevent the saving of cookies.

Your IP address shall be collected but immediately anonymised. This only allows vague localisation.

Data is processed within the realms of the regulations of §96 section 3 of the TKG and article 6 section 1 a (consent) and/or f (legitimate interest) of the DSGVO.

Our legitimate interest in the sense of the DSGVO is the improvement of our services and online presence. As the privacy of our users is important, user data is pseudonymised. User data is stored for 1 month.

Your rights

You have the right to information, deletion, limitation, transferability of data, withdrawal and objection. If you believe that the processing of your data violates data protection law or that your data protection rights have been infringed upon in any way, you can complain to the relevant supervisory body. In Austria, this is the Data Protection Authority (Datenschutzbehörde).
